

November 17, 2016 All Neighbor Meeting Question, Answer, & Comment Period Minutes

1. Neighbor & Parent – Support Castilleja plan. Thorough planning process. Traffic is better over 10 years.
2. Pretty good process. Traffic is better. Sustainability: what is the max number of students? Construction will ruin my neighborhood. Streams of traffic in Palo Alto. Consider re-location.
3. Parent moved to have daughters attend Castilleja. Glad to participate in TDM.
4. Parent. Moved to be near Castilleja. Administration cares. Parent community committed to improvement
5. Distrust: exceeds enrollment now-city enabled Castilleja to be out of compliance. Tree was removed to accommodate garage. Neighbors arborist did not agree with City's arborist.
6. Parent - supports enrollment and Master Plan. Increases access to more students.
7. Ada's Café Founder - Casti students volunteer @ Ada's, tutoring, raised money
8. Neighbor - Showed pictures of driveway exit before & after. Castilleja should relocate. Showed map of existing trees. Has not been invited to meetings.
9. Neighbor - Showed picture of driveway on Emerson. Not consulted re: location of garage and driveway. Lived at house for 20 years. Need to use shuttles, no new traffic. What is school's responsibility to neighborhood?
10. Parent, recent resident. Chose Palo Alto because of community. Daughter bikes to school.
11. Neighbor - Excellent presentation. Passionate about education. Justice for neighbors. Protect R-1 neighborhood. When does the growth end? Need Master Plan for 25-50 years. Divide Middle School & High school.
12. Parent - Moved to Palo Alto for schools. Parent. New campus is step forward.
13. Neighbor – Summary of prepared notes – does a great job of educating young ladies, 100% opposed to the project. Was active participant in 2000-2001 CUP negotiations when I was assured 415 was cast in concrete as enrollment. Castilleja violated CUP for 16 years, the neighborhood is owed 16 years of CUP compliance.

14. Resident since 1961 - Are current plans an over reach? Consider split campus.
15. Neighbor for 39 years - Support mission of school. Need relocation to grow to full potential. What are benefits to neighbors? Concerned about Construction impacts
16. Neighbor - No more growth in neighborhood. Density of students per acre compared to other area Private Schools.
17. Neighbor & parent in support of CUP plan. Reduces impact to neighbors. Enforcement. Driveway to garage should be re-located.
18. Neighbor - Neighborhood too crowded. Residential construction should stop
19. Parent in Evergreen Park - over-run with Cal Ave. Parking. Property not available for expansion. Will not benefit from school growth/improvement
20. PAUSD oversight committee member. Elementary schools grew, many with 2 stories. City supports Castilleja.
21. Opposed to project. Wants school to stay. Grow on another site. Didn't comply with 2000 CUP. Did nothing until they wanted something. Safety concerns, traffic has improved, split the campus.
